1 AN ACT relating to the Kentucky Board of Home Inspectors.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 → Section 1. KRS 198B.030 is amended to read as follows:

- 4 (1) There is hereby created the Kentucky Department of Housing, Buildings and  
5 Construction within the Public Protection Cabinet. The Governor shall appoint a  
6 commissioner to head the department. The commissioner shall receive for his or her  
7 services such compensation as the Governor shall determine.
- 8 (2) The commissioner may employ sufficient staff to carry out the functions of the  
9 commissioner's office. Neither the commissioner nor any member of his or her staff  
10 shall be employed, either directly or indirectly, in any aspect of the building industry  
11 as regulated by this chapter while employed by the Department of Housing,  
12 Buildings and Construction.
- 13 (3) The department shall serve as staff for the board of housing, buildings and  
14 construction as established by this chapter, and shall perform all budgeting,  
15 procurement, and other administrative activities necessary to the functioning of this  
16 body. The board shall prescribe the duties of the commissioner in addition to those  
17 duties otherwise delegated to him or her by the Governor or secretary, or prescribed  
18 for the commissioner by law. The department or commissioner shall submit any  
19 proposed administrative regulation to the board and shall not promulgate the  
20 administrative regulation without giving the board the opportunity to produce  
21 written comments, as required by subsection ~~(8)~~<sup>(9)</sup> of this section. If the board  
22 chooses to produce written comments, these comments shall be attached to any  
23 public submission of the administrative regulation, including any filing under KRS  
24 Chapter 13A.
- 25 (4) The department may enter into contracts or agreements with the federal  
26 government, its subdivisions and instrumentalities, other agencies of state  
27 government or with its subdivisions and instrumentalities, or with private profit or

- 1 nonprofit organizations in order to effect the purposes of this chapter.
- 2 (5) Subject to the direction of the board of housing, buildings and construction, the  
3 commissioner shall cooperate with the agencies of the United States and with the  
4 governing bodies and housing authorities of counties, cities, and with not for profit  
5 organizations and area development districts in relation to matters set forth in this  
6 chapter, and in any reasonable manner that may be necessary for the state to qualify  
7 for, and to receive grants or aid from such agencies. To these ends and subject to the  
8 direction of the board, the commissioner shall have the power to comply with each  
9 condition and execute such agreements as may be necessary, convenient, or  
10 desirable.
- 11 (6) Nothing in this chapter shall preclude any other agency, board, or officer of the state  
12 from being designated as the directing or allocating agency, board, or officer for the  
13 distribution of federal grants and aid, or the performance of other duties to the  
14 extent necessary to qualify for and to receive grants and aid for programs under the  
15 administration of the department.
- 16 (7) The commissioner is authorized to receive, for and on behalf of the state, the  
17 department, and the board of housing, buildings and construction, from the United  
18 States and agencies thereof, and from any and all other sources, grants and aid and  
19 gifts made for the purpose of providing, or to assist in providing, any of the  
20 programs authorized by this chapter, including expenses of administration. All such  
21 funds shall be paid into the state treasury and credited to a trust and agency fund to  
22 be used by the department in carrying out the provisions of this chapter. No part of  
23 this fund shall revert to the general fund of the Commonwealth.
- 24 ~~(8) [ The Kentucky Board of Home Inspectors established in KRS 198B.704 shall be~~  
25 ~~attached to the department for administrative purposes.~~
- 26 (9) (a) If the department has proposed a new or amended administrative regulation  
27 that directly and clearly relates to the work of a profession, class of workers,

1 or industry that is under the authority of any board or advisory committee that  
2 is created by statute and is controlled, superseded, administratively attached,  
3 or affiliated with the department, the department shall not promulgate the  
4 proposed administrative regulation without first receiving comments from the  
5 affected board or advisory committee, subject to the restrictions of paragraph  
6 (b) of this subsection.

- 7 (b) 1. If a proposed administrative regulation affects a board or advisory  
8 committee that qualifies under paragraph (a) of this subsection, the  
9 department shall distribute the proposed administrative regulation to the  
10 board or advisory committee.
- 11 2. The affected board or advisory committee shall be granted a maximum  
12 of sixty (60) days to submit its comments on the proposed regulatory  
13 change. If the administrative regulation is a new emergency regulation,  
14 the affected board or advisory committee shall be granted a maximum of  
15 thirty (30) days to submit its comments on the proposed regulatory  
16 change.
- 17 3. The time limits in this paragraph shall begin from the day the  
18 department submits the regulatory change and sets a date for a proposed  
19 hearing for the comments of the affected board or advisory committee. If  
20 the board or advisory committee is already scheduled to meet at a time  
21 that will give it an adequate opportunity to review the regulation and  
22 respond, the hearing may be held at that meeting.
- 23 4. If a board or advisory committee is not scheduled to meet or meets only  
24 at the call of the department, the department shall arrange for the board  
25 or advisory committee to meet at a time that will allow the board or  
26 advisory committee an adequate opportunity to review and comment on  
27 the regulation within the time limit. If the affected board or advisory

1 committee fails to comment within the time limit, the department may  
2 proceed with the administrative changes at its discretion.

3 (c) To the extent that any other statute relating to the department's authority to  
4 promulgate administrative regulations conflicts with this section, this section  
5 shall take precedence.

6 (d) If a board or advisory committee chooses to produce written comments, those  
7 comments shall be attached to any public submission of the administrative  
8 regulation, including any filing under KRS Chapter 13A.

9 (e) The rights and privileges enumerated in this subsection that apply to boards  
10 and advisory committees shall also be granted to the Kentucky Board of  
11 Housing, Buildings and Construction.

12 ~~(9)~~~~(10)~~ Any power or limitation relating to administrative regulations promulgated by  
13 the department that are subject to subsection ~~(8)~~~~(9)~~ of this section shall also apply  
14 to administrative regulations promulgated by the commissioner of the department.

15 →Section 2. KRS 198B.040 is amended to read as follows:

16 The Kentucky Board of Housing, Buildings and Construction shall have the following  
17 general powers and duties:

- 18 (1) To conduct or cause to be conducted studies to determine the needs of the building  
19 industry of Kentucky;
- 20 (2) To conduct or cause to be conducted or participate in studies of the costs of the  
21 various factors of building construction and use of buildings and to recommend  
22 programs and procedures which will minimize the cost of buildings, including the  
23 use of energy, while maintaining safety, durability, and comfort;
- 24 (3) To administer regulatory legislation relating to buildings and construction;
- 25 (4) To assume administrative coordination of the various state construction review  
26 programs and to cooperate with various federal, state, and local agencies in the  
27 programs as they relate to buildings and construction;

- 1 (5) To assume administration and coordination of various state housing programs to  
2 include:
- 3 (a) Devising and implementing procedures, in conjunction with the Department  
4 for Local Government, for attaining and maintaining an accurate count of the  
5 housing inventory in Kentucky, including information on the age, physical  
6 condition, size, facilities, and amenities of this housing, and housing  
7 constructed and demolished each year;
- 8 (b) Designing programs coordinating the elements of housing finance, production,  
9 maintenance, and rehabilitation for the purpose of assuring the availability of  
10 safe, adequate housing in a healthful environment for all Kentucky citizens;
- 11 (c) Establishing or causing to be established public information and educational  
12 programs relating to housing, to include informing Kentucky citizens about  
13 housing and housing related programs that are available on all levels of  
14 government;
- 15 (d) Designing and administering, or participating in the design and administration  
16 of educational programs to prepare low income families for home ownership,  
17 and counseling them during their early years as homeowners;
- 18 (e) Promoting educational programs to assist sponsors in the development and  
19 management of low and moderate income housing for sale or rental;
- 20 (f) Cooperating with various federal, state, and local agencies in their programs  
21 as they relate to housing; and
- 22 (g) Conducting or causing to be conducted studies to determine the housing  
23 preferences of Kentucky citizens and the present and future housing  
24 requirements of the state;
- 25 (6) To recommend state building industry policies and goals to the Kentucky General  
26 Assembly;
- 27 (7) To adopt and promulgate a mandatory uniform state building code, and parts

- 1       thereof, which shall establish standards for the construction of all buildings, as  
2       defined in KRS 198B.010, in the state;
- 3       (8) To promulgate administrative regulations providing for the proper construction of  
4       public water purification plants, other than the water treatment equipment and  
5       systems in such plants; provided, however, that any such regulations must require  
6       that applications for permits to build public water purification plants will be  
7       submitted by the department to the Energy and Environment Cabinet for that  
8       cabinet's comments. Any such regulations shall require the Energy and Environment  
9       Cabinet's comments to be completed and submitted to the department within sixty  
10      (60) days;
- 11      (9) To promulgate administrative regulations providing for the proper construction of  
12      sewage treatment plants, other than the sewage treatment equipment and systems in  
13      such plants; provided, however, that any such regulations must require that  
14      applications for permits to build public sewage treatment plants will be submitted  
15      by the department to the Energy and Environment Cabinet for that cabinet's  
16      comments. Any such regulations shall require the Energy and Environment  
17      Cabinet's comments to be completed and submitted to the department within sixty  
18      (60) days; and
- 19      (10) To promulgate administrative regulations for the safe installation and operation of  
20      plumbing and plumbing fixtures.
- 21      (11) (a) As used in this subsection, "main board" means the Kentucky Board of  
22              Housing, Buildings and Construction.
- 23              (b) If the main board has proposed a new or amended administrative regulation  
24              that directly and clearly relates to the work of a profession, class of workers,  
25              or industry that is under the authority of any board or advisory committee that  
26              is created by statute and is controlled, superseded, administratively attached,  
27              or affiliated with the main board, the main board shall not promulgate the

1 proposed administrative regulation without first receiving comments from the  
2 affected board or advisory committee, subject to the restrictions of paragraph  
3 (c) of this subsection.

- 4 (c) 1. If a proposed administrative regulation affects a board or advisory  
5 committee that qualifies under paragraph (b) of this subsection, the main  
6 board shall distribute the proposed administrative regulation to the board  
7 or advisory committee.
- 8 2. The affected board or advisory committee shall be granted a maximum  
9 of sixty (60) days to submit its comments on the proposed regulatory  
10 change. If the administrative regulation is a new emergency regulation,  
11 the affected board or advisory committee shall be granted a maximum of  
12 thirty (30) days to submit its comments on the proposed regulatory

24 the regulation within the time limit. If the affected board or advisory  
25 committee fails to comment within the time limit, the main board may  
26 proceed with the administrative changes at its discretion.

27 (d) To the extent that any other statute relating to the main board's authority to

1 promulgate administrative regulations conflicts with this section, this section  
2 shall take precedence.

3 (e) If a board or advisory committee chooses to produce written comments, those  
4 comments shall be attached to any public submission of the administrative  
5 regulation, including any filing under KRS Chapter 13A.

6 (12) Any power or limitation relating to administrative regulations promulgated by the  
7 Kentucky Board of Housing, Buildings and Construction that are subject to  
8 subsection (11) of this section shall also apply to the department and commissioner  
9 as described in KRS 198B.030~~(8)~~~~(9)~~ and ~~(9)~~~~(10)~~.

10 ➔Section 3. KRS 198B.700 is amended to read as follows:

11 As used in KRS 198B.700 to 198B.738, unless otherwise provided:

12 (1) "Applicant" means an individual who applies for a license as a home inspector;

13 (2) "Board" means the Kentucky Board of Home Inspectors established in KRS  
14 198B.704;

15 (3) "Client" means a person who contracts with a licensed home inspector to obtain a  
16 home inspection and subsequent written home inspection report;

17 ~~(4) "Department" means the Kentucky Department of Housing, Buildings and~~  
18 ~~Construction;~~

19 ~~(5)~~ "Home inspection" means a visual analysis performed for compensation for the  
20 purpose of providing a professional opinion and home inspection report by a  
21 licensed home inspector, regarding~~of~~ the condition of a residential dwelling and  
22 the dwelling's attached garages and carports, any reasonable accessible installed  
23 components, and the operation of the dwelling's systems, including any controls  
24 normally operated by the owner of the dwelling, for systems and components in the  
25 standards of practice established by the board. Home inspection shall not include a  
26 code compliance inspection, or an inspection required under the National  
27 Manufactured Housing Construction and Safety Standards Act of 1974, 42 U.S.C.

2 227.600 regarding manufactured homes;

3 ~~(5)~~~~(6)~~ "Home inspection report" means a written report prepared by a licensed home  
4 inspector for compensation and issued after a home inspection. The report shall  
5 include the following:

6 (a) A report on any system or component inspected that, in the professional  
7 opinion of the inspector, is significantly deficient;

8 (b) The inspector's recommendation to repair or monitor deficiencies reported  
9 under paragraph (a) of this subsection;

10 (c) A list of any systems or components that were designated for inspection in the  
11 standards of practice adopted by the board but that were not inspected; and

12 (d) The reason a system or component listed under paragraph (c) of this  
13 subsection was not inspected;

14 ~~(6)~~~~(7)~~ "Home inspector" means an individual who performs home inspections for  
15 compensation;

16 ~~(7)~~~~(8)~~ "Licensee" means a person who performs home inspections and who is  
17 licensed under KRS 198B.700 to 198B.738 as a home inspector; and

18 ~~(8)~~~~(9)~~ "Residential dwelling" means a structure consisting of at least one (1) but not  
19 more than four (4) units, each designed for occupancy by a single family, whether  
20 the units are occupied or unoccupied.

21 →Section 4. KRS 198B.702 is amended to read as follows:

22 KRS 198B.700 to 198B.738 shall apply to an individual who conducts home inspections  
23 for compensation, but shall not apply to the following:

24 (1) An individual who is acting within the scope of the individual's employment as:

25 (a) A code enforcement official for the state or a political subdivision of the state;

26 or

27 (b) A representative of a state or local housing agency or an individual acting

- 1 under the authority of the United States Department of Housing and Urban  
 2 Development;
- 3 (2) An individual who is acting within the scope of the individual's license as a  
 4 licensed:
- 5 (a) Architect under KRS Chapter 323;
- 6 (b) Professional engineer under KRS Chapter 322;
- 7 (c) Plumbing contractor or journeyman plumber under KRS Chapter 318;
- 8 (d) Electrician, master electrician, or electrical contractor under KRS Chapter

13 ➔ Section 5. KRS 198B.704 is amended to read as follows:

14 (1) There is created *an independent agency of state government*~~[a board]~~ to be known  
15 as the Kentucky Board of Home Inspectors, *which shall be attached to the Office*  
16 *of Occupations and Professions in the Public Protection Cabinet for*  
17 *administrative purposes.*

18 (2) The board shall be composed of *nine (9)*~~[ten (10)]~~ members appointed by the  
19 Governor *as follows:*~~[.]~~

20 (a) Five (5) of the *board* members shall:

21 *1. Have been actively engaged in performing home inspections in*  
22 *Kentucky for at least five (5) years immediately before the member's*  
23 *appointment to the board, or have completed no less than one hundred*

 7 board shall have regular meetings at times specified by a majority vote of the board.  
 8 The chairman may call special meetings at any time. He shall call a special meeting  
 9 on written request by two (2) or more members of the board. A majority of the  
 10 board shall constitute a quorum to transact business.

11 (10) All staff assistance deemed necessary by the board to carry out the functions and  
 12 duties assigned to it in KRS 227.550 to 227.660 shall be provided by the  
 13 department and shall function under the supervision of the head of the department.

14 (11) The provisions of KRS 198B.030~~(8)~~~~(9)~~ and ~~(9)~~~~(10)~~ and 198B.040(11) shall not  
 15 apply to the board.

16 ➔Section 18. KRS 227A.040 is amended to read as follows:

17 (1) The department, with assistance from the Electrical Advisory Committee, shall  
 18 administer and enforce the provisions of KRS 227A.010 to 227A.140 and shall  
 19 evaluate the qualifications of applicants for licensure.

20 (2) The department may issue subpoenas, examine witnesses, pay appropriate witness  
 21 fees, administer oaths, and investigate allegations of practices violating the  
 22 provisions of KRS 227A.010 to 227A.140 or the administrative regulations  
 23 promulgated under KRS 227A.010 to 227A.140 and KRS Chapter 13A.

24 (3) The department shall conduct hearings under KRS Chapter 13B and keep records  
 25 and minutes necessary to carry out the functions of KRS 227A.010 to 227A.140.

26 (4) The department, with assistance from the Electrical Advisory Committee, shall  
 27 evaluate the qualifications of applicants and issue licenses to qualified candidates.

- 1 (5) The department shall renew licenses.
- 2 (6) The department may:
- 3 (a) Refuse to issue or renew a license;
- 4 (b) Suspend or revoke a license;
- 5 (c) Impose supervisory or probationary conditions upon a licensee;
- 6 (d) Impose administrative disciplinary fines;
- 7 (e) Issue written reprimands or admonishments; and
- 8 (f) Take any combination of the actions permitted in this subsection.
- 9 (7) The department may seek injunctive relief in the Circuit Court of Franklin County,  
10 in the county in which the violation occurred, or in the county where the business of  
11 the accused is located to stop any unlawful practice in KRS 227A.010 to 227A.140  
12 and administrative regulations promulgated thereunder. The department may also  
13 seek injunctive relief for unlicensed persons who inappropriately use the title  
14 "electrical contractor," "electrician," or "master electrician."
- 15 (8) The department, with comments and advice from the Electrical Advisory  
16 Committee if required by KRS 198B.030~~(8)~~~~(9)~~ and ~~(9)~~~~(10)~~, may promulgate  
17 administrative regulations to create a code of ethics and procedures governing the  
18 licensure of electrical contractors, electricians, and master electricians.
- 19 (9) The department may enter into reciprocal agreements with other states having  
20 licensure, certification, or registration qualifications and requirements substantially  
21 equal to those of this state.

22 →Section 19. KRS 236.030 is amended to read as follows:

23 After reasonable notice and opportunity to be heard in accordance with KRS Chapter  
24 13A, the commissioner of housing, buildings and construction, upon advisement and  
25 subject to comment by the board under the requirements of KRS 198B.030~~(8)~~~~(9)~~ and  
26 ~~(9)~~~~(10)~~ and 198B.040(11), shall, by administrative regulation, fix reasonable standards  
27 for the safe construction, installation, inspection, and repair of boilers, pressure vessels,

1 and associated pressure piping in this state. Such administrative regulations shall be  
2 enforced by the Department of Housing, Buildings and Construction, Division of  
3 Plumbing.

4 →Section 20. KRS 318.077 is amended to read as follows:

5 The committee shall hold hearings, upon adequate notice to affected parties specifying  
6 the matters to be considered before the submission to the commissioner of its suggested  
7 amendments to the code. No amendment of the code or any other related regulation shall  
8 be issued or promulgated by the department without the prior review and comment of the  
9 committee under the requirements of KRS 198B.030~~(8)~~~~(9)~~ and ~~(9)~~~~(10)~~ and  
10 198B.040(11). Any person aggrieved by any rule, regulation, or amendment approved by  
11 the department, within 30 days after such action has become final, may appeal therefrom  
12 to the Circuit Court. For the purposes of this section, "persons aggrieved" shall include  
13 any person directly or indirectly injured or threatened with injury on account of any such  
14 regulation, rule, or amendment, whether or not such person was a party to the proceedings  
15 out of which the order, rule, regulation, or amendment arose.

16 →Section 21. KRS 318.130 is amended to read as follows:


17 In order to administer this chapter, the department shall promulgate and thereafter from  
18 time to time may amend a code to be known as the Kentucky State Plumbing Code,  
19 regulating the construction, installation, and alteration of plumbing and plumbing fixtures  
20 and appliances, house sewers and private water supplies, and methods and materials to be  
21 used therein within this state, using as a minimum standard the basic principles of the  
22 National Plumbing Code Coordinating Committee, as evidenced by that committee's final  
23 report of 1951 with variations thereof or additions thereto as the committee considers are  
24 warranted by local, climatic, or other conditions. The code may also designate the number  
25 of plumbing fixtures for public buildings. The department may adopt any other  
26 reasonable rule or regulation to administer this chapter if the rule or regulation has been  
27 subject to review and comment by the committee under the requirements of KRS

1 198B.030~~(8)~~~~(9)~~ and ~~(9)~~~~(10)~~ and 198B.040(11). No rules or regulations so approved by  
2 the committee shall become effective except upon adoption by the department, in  
3 satisfaction of the requirements of KRS Chapter 13A. The department shall furnish to the  
4 committee proposed amendments to the code for the committee's review and comment  
5 prior to their adoption by the department. The department shall not promulgate any rules  
6 or regulations related to this chapter without granting the committee the opportunity to  
7 comment on the administrative regulation.
