1 AN ACT relating to reorganization.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. The General Assembly hereby confirms the Governor's Executive
4 Order 2014-987, dated December 17, 2014, to the extent it is not otherwise confirmed or
5 superseded by this Act, relating to the reorganization of the Department for Libraries and
6 Archives in the Education and Workforce Development Cabinet. The reorganization
7 establishes the Division of Library Services; abolishes the Division of State Library
8 Services, the Division of Field Services, and the Division of Administrative Services; and
9 renames the Division of Public Records to the Division of Archives and Records
10 Management.

Technical Correction by the Reviser of Statutes

The following technical correction shall be made in the printed copy of:

HB 413/GA

(15 RS BR 534)

On page 2, the signature page, in the notation “15 RS HB 43/GA” in the upper right-hand corner, delete “43” and insert “413” in lieu thereof.

Through an inadvertent manifest clerical or typographical error during the preparation of the signature page to be added to HB 413/GA, as it was enrolled on March 25, 2015, a notation on the signature page indicated that it was for “HB 43/GA” instead of “HB 413/GA.”

The official actions of the General Assembly concerning HB 413 clearly indicate passage of HB 413/GA and are correctly reflected in the *Legislative Record* of final legislative action, and in documentation of the transfer of the passed bill between the House and Senate and its delivery to the Governor.

The bill’s cover and single page of bill text both correctly indicate that the bill being signed was HB 413/GA, not HB 43/GA. Under the authority of KRS 7.136 and KRS 446.310, this inadvertent typographical error should be corrected in the bill presented to the Governor.
