

ORDINANCE NO. 0-4-83

AN ORDINANCE RELATING TO THE ACTUAL ANNEXING AND MAKING A PART OF THE INCORPORATED AREA OF THE CITY OF FLORENCE, KENTUCKY CERTAIN UNINCORPORATED TERRITORY CONTIGUOUS TO THE PRESENT CORPORATE LIMITS OF THE CITY OF FLORENCE, KENTUCKY (SAFI-LIGGETT PROPERTY)

WHEREAS, the City Council of the City of Florence, Kentucky has previously enacted Ordinance No. O-38-82, proposing and stating an intention to annex certain property contiguous to the present corporate limits of the City of Florence, Kentucky situated on the easterly side of LaCresta Road, and

WHEREAS, more than sixty (60) days have passed since the publication of Ordinance No. O-38-82 and no petition has been received by the Mayor of the City of Florence, Kentucky opposing the proposed annexation, and

WHEREAS, the subject property and the process followed for annexation of it to the City of Florence, Kentucky conforms to the requirements of Chapter 81A of the Kentucky Revised Statutes, it being desirable to annex the unincorporated territory and it is urban in character or suitable for development for urban purposes without unreasonable delay.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF FLORENCE, KENTUCKY AS FOLLOWS:

SECTION I

That all requirements of Chapter 81A of the Kentucky Revised Statutes having been met and satisfied, the real estate which is more particularly described in Section II of this Ordinance, this property being in unincorporated territory situated on the easterly side of LaCresta Road and being contiguous to the present corporate limits of the City of Florence, Kentucky shall be and is hereby annexed to and made a part of the corporate territory of the City of Florence, Kentucky.

SECTION II

The real estate which is annexed to the City of Florence, Kentucky by this Ordinance is more particularly described as follows:

Being Lot No. Six (6) of the Shamrock Hill Subdivision, as shown in Plat Book 3, Page 35 of the records of Boone County, Kentucky at Burlington. Said lot fronts eighty (80) feet on the eastwardly side of LaCresta Road and extends back in an eastwardly direction between parallel lines one hundred and fifty (150) feet in depth.

SECTION III

That it is desirable to annex the property which is the subject of this Ordinance as it is urban in character or suitable for development for urban purposes without unreasonable delay, in accordance with Chapter 81A of the Kentucky Revised Statutes.

SECTION IV

That the real estate which is annexed to the City boundaries of Florence, Kentucky by this Ordinance has been annexed with the consent of the owners of the property.


